## EMERGENCY RESPONSE PLAN SPECIFIC TO A COVID-19 SITUATION

NEC's COVID-19 Compliance/Resource Officer will monitor activities to ensure compliance with social distancing and face covering requirements. He or she will intervene if non-compliance is identified and will interact with local health authorities to understand and implement their COVID-19 policies including reporting and contact-tracing assistance, as necessary. In addition, he or she shall ensure that adequate signage is present throughout the venue and ensure that adequate hygiene materials are available in common areas and washroom facilities. Finally, he or she will designate and prepare an isolation area and monitor entry screening personnel/security measures.

#### AT THIS EVENT:

- All personnel, volunteers and show staff will enter through the South Entry Door leading in from the Facility's Employee parking lot. Each shall wait at the check-in station to have their temperatures taken. If any individual's temperature is above 99.5 degrees, he or she shall be asked to leave the grounds, and facility staff will disinfect the area immediately. \*Exception: Healthcare personnel who have treated patients using appropriate medical-grade PPE during the course of performing professional duties are exempted from this restriction.
- All individuals are required to self-monitor their temperature once daily prior to entering the competition grounds. Anyone with a temperature of 99.5° F (37.5° C) or higher may not enter the facility. Anyone who: 1) exhibits COVID-19 symptoms, 2) has tested positive for COVID-19 within last two weeks, or 3) has been in contact with someone who has tested positive for COVID-19 within the last two weeks may not enter the show grounds
- All individuals are required to wear a facemask or face covering when in any setting where there
  is a possibility of being within six feet of other individuals and when not mounted on a horse. This
  includes other individuals within the person's immediate household. You can find
  recommendations for proper use of face masks and face coverings via the Centers for Disease
  Control & Prevention website.
- All individuals must practice physical distancing at all times while on the competition grounds by staying at least 6 feet (about 2 arms' length) from any person who is not a member of their immediate household. Members of the same household are still required to wear masks or face coverings when there is a possibility of being within six feet of any other individuals, including members of their own household.



## **COVID-19 EMERGENCY RESPONSE ISOLATION PLAN**

Any person suspected to have COVID-19 or similar symptoms will be quickly removed from the venue (or isolated on-site until they can arrange transportation) to avoid further contact with other individuals.

**DESIGNATED AND PREPARED ISOLATION AREA ON-SITE:** If an individual on the grounds is displaying symptoms or has a temperature of 99.5° F (37.5° C) or higher according to the USEF COVID-19 Action Plan and is unable to travel independently and immediately away from the competition grounds, the individual must be asked to remain in an isolation area away from others until private transportation can be organized.

#### **AT THIS EVENT**:

The **isolation room** will be in the **East Arena Show Ofice**. Anyone with a fever and/or showing symptoms will be escorted to this location until transportation can be arranged. Following use of the isolation room, facility staff will properly disinfect the area and surrounding areas the person may have touched.

Alternate Route:	I-70 to Lake St. Louis Blvd. exit #214, south continues across Hwy 40/61 (I-64) overpass to NEC



## **DISASTER/EMERGENCY PLANS AT NEC**

## **Severe Weather**

- Manager, Technical Delegate, Show Staff & Volunteers
  - o facilitate calm movement of horses and competitors to safe areas.
- Announcer, Secretary or Head Scorer
  - use the facility PA phone system to issue information & instructions on evacuation to safe areas to the entire facility.

#### IN THE STABLING BARNS AND ARENA

The facility is engineered so that the center aisles, restrooms and wash stalls are severe weather safe areas; Outside doors may be partially closed

People to center aisles, restrooms & wash stalls

Horses go to stalls

#### IN THE LOBBY AND SHOW OFFICE AREAS

People to main WEST arena restrooms

#### IN THE RV AND PARKING LOTS

People evacuate the lots to the nearest barn's center aisle, restrooms and wash stalls

## **Fire Outbreak**

- Technical Delegate, EMT
  - Go to scene of the fire and assist where possible with control of fire and/or with safe evacuation of people and animals to safe areas
- Manager and Secretary
  - Direct emergency vehicles to fire and assist with clearing of fire lanes
- Show Staff & Volunteers
  - facilitate calm evacuation of people and animals to safe areas
- Announcer or Head Scorer
  - use the facility PA phone system to instruct clearing of fire lanes and to direct people to safe areas throughout the entire facility



The facility has multiple barns, each equipped with multiple fire extinguishers and water spigots. Everyone should evacuate the area near the fire itself

People evacuate to outside and away from the fire scene, preferably 100 yards or more

Horses go to stalls in barns away from the fire scene

People on horseback go to outdoor arena if more than 150' from fire scene

#### IN THE LOBBY AND SHOW OFFICE AREAS

People move outside to the monument sign along Lake St Louis Blvd

#### IN THE RV AND PARKING LOTS

People evacuate to area away from fire, preferably 100 yards or more

### **Minor Medical**

#### Manager or Secretary

- Call EMT, Technical Delegate and Manger/Secretary
- Identify over the phone specific details as known

#### Ring Steward

 Complete accident report for any accidents involving a fall from horseback regardless of degree of injury including none

#### • Technical Delegate, EMT

o Go to scene of minor medical emergency and assist with minor medical situation

#### LOCATION OF MINOR MEDICAL STATION

An EMT is stationed in the West Arena, often in the café seating area or lobby.

## **Major Medical**

### Manager or Secretary

- Call EMT, Technical Delegate and Manger/Secretary
- o Identify over the phone specific details as known

### • Technical Delegate, EMT

o Go to scene of major medical emergency and assist with major medical situation

#### Head Scorer

o Dial 911 and coordinate with emergency vehicles accurate directions to accident location



#### Show Staff & Volunteers

 use the facility PA phone system to clear horses and people from accident area and facilitate entry of emergency personnel, vehicles and equipment

#### Ring Steward

 Complete accident report for any accidents involving a fall from horseback regardless of degree of injury including none

## **Catastrophic Medical**

### Manager or Secretary

- o Call EMT, Technical Delegate and Manger/Secretary
- o Identify over the phone specific details as known
- Coordinate helicopter landing on South side of West Arena in Employee Parking or in front parking lot near West main building.

#### • Technical Delegate, EMT

Go to scene of catastrophic medical emergency and assist with medical situation

#### Head Scorer

Dial 911 and coordinate with emergency vehicles accurate directions to accident location

#### Show Staff & Volunteers

 use the facility PA phone system to clear horses and people from accident area and facilitate entry of emergency personnel, vehicles and equipment

#### Ring Steward




# **ISOLATION PROTOCOLS**

In the event one or more horses are required to be isolated from the rest of exhibitors due to illness, an **ISOLATION ZONE** will be established in **BARN 6** of the National Equestrian Center.



Barn 6 is a separate enclosure, located approximately 600 feet from the nearest stabling area used by exhibitors.

The **ISOLATION ZONE** will include **STALLS 745-762**, the aisle onto which those stalls open, the wash-rack adjoining stall 745, and the exterior loading door adjacent to stall 753.
