To qualify for a GAIGUSDF Regional Championship horse/rider combinations must earn a total of two qualifying scores (each score must be the average of all judges officiating in a designated Great American/USDF qualifying class), at one or more USEF licensed/USDF-recognized Dressage Competitions. Both scores may be from the same judge or combination of judges. Competitors who earned an applicable score prior to June 1 may notify USDF that they would like to pay the qualifying fee to have the score recorded as a Great American/USDF qualifying score.

Awards: Awards (in classes of 3 or more in the division (AA, Jr/Yr, Open) and six ribbons. High Score for each Level and Division (In each division in which there are 3 or more competitors), Intro through 4th. High Score FEI for each Division (AA, Open, Jr/YR.) (Does not include Freestyle, YH or Opportunity at any Level or division.) Check **www.tndressage.com** for final list.

National Dressage Pony Cup Award will be presented for scores earned in Saturday classes #281, 282. **PONY MEASUREMENT:** Measurement of ponies will be conducted by appointment at the show. All expenses related to the measurement will be the responsibility of the owner of the pony or ponies up to \$100.00. Contact the Show Manager if you want to arrange to have a pony measured. *Only measured ponies may participate in Pony Classes.* Expenses may include vet travel time and trip fees, and any other expenses not normally associated with a dressage show.

The Jockey Club Thoroughbred Incentive Program (T.I.P.) is offering ribbons and prizes to the high score (including a FEI high point) Thoroughbred at the CLASSIC show (Saturday Classes). Eligible horses must provide T.I.P. numbers to event organizer with entry. For more information, visit www.tjctip.com

Master's Classes: Register in the show office for High Point Award. Open to entries in which the combined ages of Horse and Rider equal at least 65 years on the date of the class. Riders are responsible for signing up in the show office. Award will be given for "Ole South Dressage Prelude" and "Ole South Dressage Classic."

ENTRIES: Entries accepted on a first come, first served basis. Management reserves the right to combine or divide classes, add or substitute judges or make any changes as required by circumstances. Riders who are not US citizens please include a copy of foreign competitor's license or USEF Card. *Each Entry must have copies of All Required Documentation attached (If your horse is from out of state Health Cert. is required). Include LEGIBLE e-mail address and phone number on entry. Emailed entries will not be accepted. Acknowledgements of entry receipt and notification of problems with the entry will be emailed to the address that you provide. PLEASE READ AND RESPOND!*

ENTRY FORMS: are available on www.Horshowoffice.com or www.TNdressage.com or on the last page of this document.

CTDA Membership: Everyone who has an active (by opening date for Ole South) CTDA membership is eligible for 2 FREE bags of shavings. If for some reason entrant scratches entire show or does not check in for Ole South, the shavings will not be awarded.

Make check payable to CTDA, no entry will be processed or classes scheduled that have not included payment and mail with entry, USDF/USEF documents and copy of negative Coggins to Secretary. Entries must be received by the closing date. *(Waive signature requirements for receipt).* Entries received after closing date will be placed on a waiting list.

Returned check policy: Void entry and incur a \$60 charge. Entries placed on a waiting list until a money order, certified check or cash is received. Management reserves the right to ask entries be paid by money order or certified check with the entry by any individual that has previously forfeited or bounced checks for any of the CTDA competitions.

ON LINE ENTRIES: www.HorseShowOffice.com is the website for online entries to this show. It is also the source for legible, "mistake proof" typed entries even if you do not choose to pay by bank draft through them. Or you can print the information and send with a check (payable to CTDA) to the entry secretary.

ENTRY DOCUMENTATION REQUIREMENTS FOR NON-QUALIFYING RIDES:

- Current USEF membership (or n/m fees) for Rider, Owner and Trainer, Coach
 - Current USDF membership (or n/m fees, number) for Rider and Owner. **Rider's USDF membership may be either Participating or Group, Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is a non-member ID #, the USDF non-member fee must be paid.**
 - USDF Horse ID.
 - Current negative Coggins and proof of vaccinations as per Rule GR845 (Link to USEF Rule GR845 <https://www.usef.org/documents/drugsMeds/2016/2016GR08845VaccineRule.pdf> Link to form for tracking vaccinations: <https://www.usef.org/documents/membership/EquineVaccinationRecord.pdf>) or 30 day health certificate. (Current FEI Passport acceptable).
- All documentation must be legible and clearly state the name of the horse as entered in the show.
- For Adult Amateur classes - USEF membership card must declare Amateur.
 - Juniors and Young Riders must include birthdate.
 - Freestyle entries - copy of a 6 % + at the highest test of the MFS level or higher.

FOR GAIG / USDF QUALIFYING CLASSES ALSO INCLUDE:

- Check "Qualifying" where applicable and add \$15 per Qualifying class.
- Copies of USEF and USDF Horse Registrations (not HID #s).
- Rider must have current Participating USDF membership; Owner must have current Participating or Business USDF membership.
- Rider and Owner, must have current USEF membership.

ALL ENTRIES must have **THREE SIGNATURES** - Rider, Owner and Trainer. Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements).

Freestyle: music must be given to the announcer at least four hours before the scheduled ride time. Coordinate a sound check time with the announcer. The format for freestyle music can be done electronically and emailed to the announcer. State level on Test of Choice classes.

GUEST HORSE: Non Competing horses are welcome. Send a completed entry form with a \$35 guest horse fee plus the \$40 Office fee. Submit a current Coggins,(Proof of vaccination Rule GR845 applies to Guest Horses) with entry and pay either stabling or day parking. Competing horses will take preference over guest horses if warm up areas are crowded.

Refunds: Before closing date full refund, less office fee. No refunds after closing date, including cancellation of classes due to inclement weather.

STABLING: Permanent 10 X 10 stalls, with sliding doors. . Barns have wash racks, modern bathrooms/showers, vending areas. Pre Order extra shavings to have them available for your arrival. **For Groups: Specify ONE name to be assured of stabling together.**

TIMES: Official times available on line at www.HorseShowOffice.com. Unofficial times posted before show at www.TNDressage.com. Entry acknowledgements will be emailed. Please include LEGIBLE email addresses and telephone number on entry form.

ARENAS: Air conditioned Indoor arena. Competition: 20 X 60 meters, two indoor, (side by side). Warm-up: One covered, and separate area for lunging. All outdoor rings are sand/quarter down mix. Indoor rings are clay/sand mix with coliseum seating. All arenas are open for schooling from Thursday noon until 8:00 pm. On Friday and Saturday from end of competition until 8:00 pm. Warm up arenas are open for schooling any time.

HOSPITALITY: Light concessions available on grounds.

OTHER: All mounted riders must wear protective headgear as defined in the USEF Rule Book under DR120.6 and in compliance with GR801.

EACH ENTRY MUST include all required documentation. For on line entries follow the instructions. <http://www.eqverification.org/> is an excellent site to print USEF / USDF card copies for horses, riders and owners all on one page...no photocopying necessary

DIRECTIONS: **From Nashville or Chattanooga:** I-24 to exit 78B (Highway 96) toward Murfreesboro. At the first traffic light, turn left on Thompsons Lane. Go 5.7 miles to entrance on left. **From Franklin:** I-65 S. to I-840 E. Get off at Exit 55A - Murfreesboro, Hwy 41/Hwy 70S. Go 2 miles to Thompsons Lane and turn left. Go 3.8 miles to Miller Coliseum on left.

ALL dogs must be leashed, no barking dogs allowed in coliseum.

Additional Information: All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise. The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees. Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste. No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented to appear before an audience.

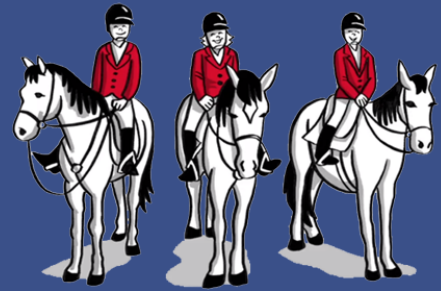

US EQUESTRIAN FEDERATION RULES

"EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH."

US EQUESTRIAN FEDERATION rules are in force from the moment show management allows access to the show grounds. This includes conduct, correct saddlery and equipment, and attire.

USEF MEMBERSHIP STATEMENT DR901.9 Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

MOTORIZED VEHICLE RULE In accordance with GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Sharps Containers Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. **Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.** Please do not use garbage cans for this material. If local law has different requirements, local law will prevail.

Protective Headgear Rule DR120.6 Current USEF helmet policy will be strictly enforced.

IT IS THE RIDER'S RESPONSIBILITY TO KNOW RULES FOR SHOWING AT A DRESSAGE SHOW.

Due to COVID-19 the show committee plans to implement social distancing policies at the shows and operate under a CLOSED SHOW OFFICE to help protect exhibitors, staff, and officials.

Some of these policies will include:

- Anyone who exhibits COVID-19 symptoms, has tested positive for COVID-19 within last two weeks, or *has been in contact with someone who has tested positive for COVID-19 within the last two weeks cannot enter the competition grounds. *Exception: Healthcare personnel who have treated patients using appropriate medical grade PPE during the course of performing professional duties are exempted from this restriction
- Staff, officials, and volunteers will have their temperatures taken upon arrival each morning.
- Participants and their support crew are required to self-monitor their temperature once daily prior to entering the competition grounds.
- All participants, including licensed officials and volunteers, must provide emergency contact information and execute an updated Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement required by USEF, as a condition of participation.
- Anyone with a temperature of 99.5° F (37.5° C) or higher may not enter the facility.
- All attendees are required to social distance by a minimum of six feet.
- A staff member patrol the barn areas to remind people to stay six feet apart from each other, to wear masks when within six feet of another.
- A facemask or face covering is required for all staff, officials, volunteers, service providers, and participants in any setting where there is a possibility of being within six feet of any other individual, and when not mounted on a horse. Competitors and their support crew are required to provide their own masks.
- All entries **must be perfect** to facilitate pick up in Barn A. No office visits will be permitted.
- Scratches and rider/horse changes will be communicated via text, email and/or phone with the show office.
- Issues that need staff or official's attention will be initiated by a phone call to the office and, if needed, the appropriate staff or officials will address the item at the exhibitor's stabling area.
- Stabling charts will be created using as much space as possible between barns.
- Competitors are encouraged to not spend extra time at the Miller Coliseum outside of their ride times and time to properly attend to their horses.
- Competitors may not report to their warmup area more than one hour before their ride time.
- The number of horses in each warmup area may be limited.
- Spectators will not be permitted.
- The Competition Organizer has the authority under GR 702.1 and GR914 to remove from the facility any person who does not comply with the regulations and requirements in effect at the competition.
- **This is a fluid situation and all policies are subject to change on a daily basis.**

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



2020 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2020 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Junior Active, Senior Active, or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record. A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:
