NOTES:

Dressage Tests are USDF/USEF 2019, Combined Training Dressage Tests are USEF/USEA 2018, DSE Scoring Sheet is USDF 2019 and Western Dressage Tests are WDDA 2019.

*TOC – Test of Choice – Specify Test to be ridden on entry.

**CTs (31-42) are a combined test that include the specified dressage test and a stadium jumping round.

***Leadline (Class 49) – Rider must be 6 years of age or less and led throughout the class by an adult who is 18 years of age or older.

****Jumper Classes (51-54) are placed based on the shortest time to complete the jump round.

CLASS & SHOW FEES:

- Dressage Only Classes - \$35 (Classes 1 – 27 & 50)
- Combined Tests - \$50 (Classes 28 – 42)
- Dressage Seat Equitation - \$30 (Classes 43-48)
- Jumpers - \$25 (Classes 50-52)
- Leadline \$15 (Class 49)
- Office Fee - \$10 (If entered online through Horse Show Office or entry mailed via USPS)
- Additional Office Fee - \$5 (Add \$5 to Office Fee if entered by emailing entry)
- Stabling – Contact Lynn Conto at conto@bellsouth.net. Payment for stalls is made directly to Lynn Conto.
- Guest Horse - \$20 plus Office Fee. Guest horses **ARE NOT SHOWN** in classes but are brought to the show for experience. The guest horse maybe led or ridden but must have a bridle number before being mounted or walked around the show grounds.
- Late Fee - \$15 (Entry and/or payment received after October 28, 2020 (11:59pm))

NOTE: Documentation required with Entry includes:

1. **Entry Form**
2. **Coggins (EIA Report not over one year old – dated October 24, 2019 or later)**
3. **COVID Agreement**

ENTERING THE SHOW (A separate entry is required for each horse/rider combination):

1. ONLINE at Horse Show Office

- Go to www.horseshowoffice.com to enter online. After entering and paying, download the entry and COVID Agreement. Sign and upload the Entry Form signature page, COVID Agreement and Coggins Report to Horse Show Office to complete the entry.
- A confirmation email will be sent from Horse Show Office to the email address provided and include a link if documents or payment are required.

OR

2. MAILED to the Show Manager

- Mail the signed entry form, signed COVID Agreement, and Coggins to: Carol Freligh, 1621 Middendorf Road, Hartsville, SC 29550. Payment can be made by check made payable to SCDCTA and included with the mailed entry or paid through Paypal at [paypal.me/SCDCTA](https://www.paypal.com) or using a credit card by calling Carol Freligh (843-857-6229). Returned checks will incur a \$50 fee.

3. EMAILED to the Show Manager

- Email the signed entry form, signed COVID Agreement and Coggins to: frelighc2805@gmail.com. Emailed entries will incur an additional fee (\$5) due to the added administrative costs. Late Entries

- Refunds can be requested through the closing date (10/26/20) less the office and Paypal fees (if applicable). No refunds after the closing date (10/26/20).
- Entries received after the closing date (10/26/20) will be required to pay a \$15 late fee. Late entries will be accepted until Wednesday, 10/28/20 at noon.
- Organizers reserve the right to refuse any entry. Organizers can combine, cancel, change or split classes and change show officials without notification to entrants.

Awards:

- First through Sixth place ribbons will be awarded.
- A Dressage High Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the highest score. A Combined Training (CT) Low Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the lowest score. Attire: An ASTM Approved helmet must be worn AT ALL TIMES when mounted and footwear should have a distinguishable heel while riding. Otherwise, casual attire is acceptable.

Arenas: One dressage arena will be used for all Dressage Classes. The Dressage Arena is 20m x 40m for all CT classes, Western Dressage Intro, Intro Dressage and Leadline. These classes will be scheduled before the Dressage Arena is changed to 20m x 60m for Dressage Seat Equitation and Training through FEI Dressage Tests. A separate jump arena will be used for CT stadium and the Jumper classes.

Ride Times: Dressage and jumping times will be emailed to the email address on the entry form by Friday, 10/30/20. Please contact the show manager, Carol Freligh, at frelighc2805@gmail.com or 843-857-6229 if you have questions or have any special requirements.

AGREEMENT TO PRACTICE THE EVENT ORGANIZER COVID-19 MITIGATION PROTOCOL
